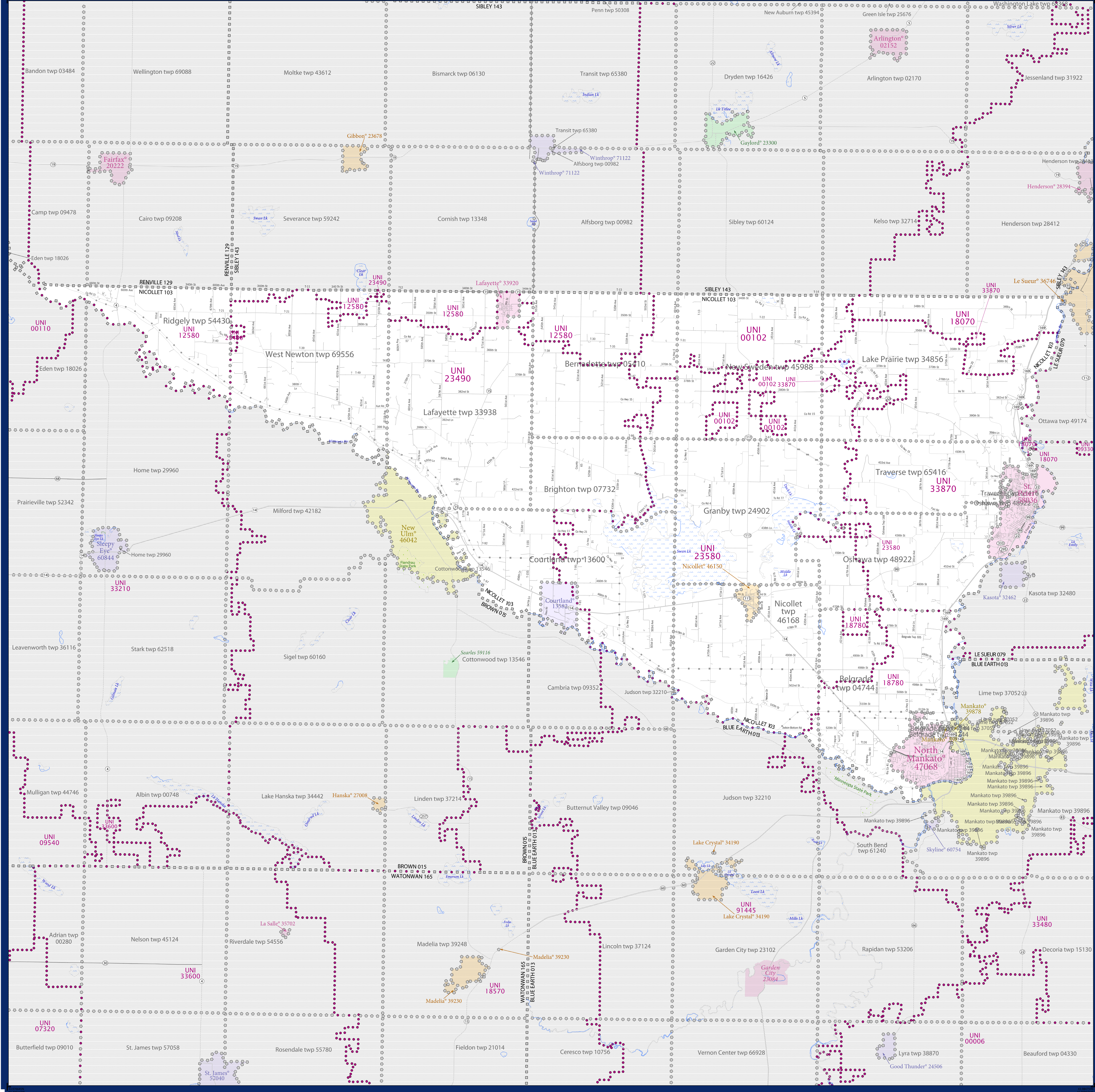


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Nicollet County, MN

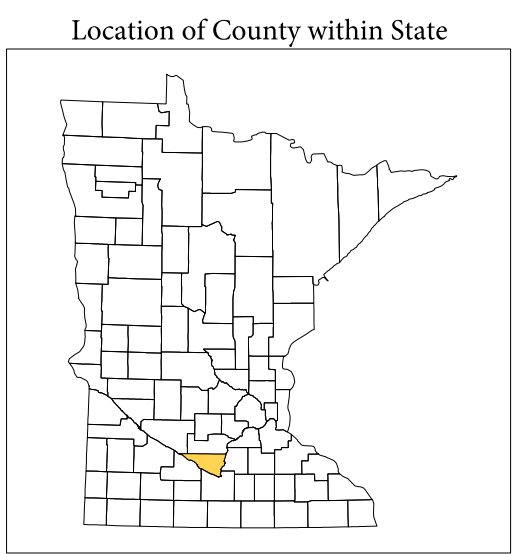
